

CITY COUNCIL MEETING DECEMBER 19, 2016

The Greenville City Council convened in the Council Chamber at City Hall on Monday, December 19, 2016, at 5:30 p.m. for a regular meeting. Mayor Dexter McLendon called the meeting to order. City Clerk-Treasurer Dee H. Blackmon called the roll and recorded the following members present: Mayor McLendon, Councilmembers Ed Sims, Tommy Ryan, Jimmy Lawson and Jeddo Bell. Councilmember Bryan Reynolds was absent. Mayor McLendon led those attending in the Pledge of Allegiance to the American Flag. Councilmember Bell delivered the invocation.

APPROVAL OF MINUTES:

Mayor McLendon advised each councilmember had received for review a copy of the proposed minutes for the Regular Council Meeting held on December 12, 2016. He asked if there were any additions, deletions or amendments to the minutes as presented.

Councilmember Bell moved to dispense with the reading of the minutes and approve the minutes for the December 12, 2016 Regular Council Meeting as drafted. Councilmember Lawson seconded the motion. Mayor McLendon announced the **motion carried** with a unanimous vote of the Council.

RESOLUTION 2016-96. TO APPROVE STREET LIGHT MODIFICATION FOR GLENDALE AVENUE NORTH OF NORTHGATE ROAD.

Councilmember Sims moved to adopt Resolution 2016-96 authorizing the addition of a street light at Glendale Avenue North of Northgate Road at a cost of \$62.40 per month (\$748.80 annual cost). Councilmember Bell seconded the motion. Mayor McLendon announced the **motion passed** with unanimous vote of the Council.
